

## ADVERTISEMENT FOR BIDS

Separate sealed bids for, the Madison Township 2023 Road Resurfacing Project, MADISON TOWNSHIP, RICHLAND COUNTY, OHIO will be received by the Madison Township Trustees UNTIL:

7:30 PM LOCAL TIME JUNE 8, 2023

at which time they will be opened and read aloud. Public bid opening will be held at 1408 Ashland Rd, Mansfield, OH 44905. Mailed bids will be received at 817 Expressview Dr, Mansfield, OH 44905. Hand delivered bids will be received at 1408 Ashland Rd, Mansfield, OH 44905 at the time of opening. Bids shall be in a sealed envelope and clearly marked "**BID FOR Madison Township 2023 Road Resurfacing**" along with the company name.

Plans and bid documents shall be obtained at RB Printshop, Inc. (RBPrintshop.com, Telephone: 419-524-2781). The bidder must obtain the plans, specifications, etc. at their own expense and the cost is non-refundable. The plans and specifications may be obtained on or after May 25, 2023.

- A. Each bidder requesting that a set of plans, specifications, etc. be mailed to the bidder shall pay the additional shipping and handling charges to RB Printshop, Inc.
- B. The list of those firms or persons obtaining plans and bid documents will be reported at RB Printshop, Inc.
- C. Bid proposals shall be submitted on forms furnished by RB Printshop, Inc.

Each proposal must contain the full name of the party or parties making the same and all persons interested therein, and must be accompanied, pursuant to Section 153.54 of the Ohio Revised Code, by a satisfactory BID GUARANTY: either a BID BOND or a BID AND PERFORMANCE PAYMENT BOND executed by the bidder and an acceptable surety, in an amount equal to one hundred percent (100%) of the total amount for each individual proposal; **OR** by a certified check, cashiers check, or a letter of credit pursuant to Chapter 1305 of the Ohio Revised Code in an amount equal to ten percent (10%) of the total amount for each individual proposal, payable to the Board of Madison Township Trustees as a guarantee that if the proposal is accepted, a contract will be entered into.

The Owner reserves the right to waive any informalities or to reject any or all bids.

Each bidder must have current ODOT prequalification for Work Type 10, and present their Certificate of Qualification at the time of the bid opening.
